- * That the participant(s) will not use Sliders's facilities and activities whilst under the influence of any drugs or alcohol.
- * I and as parent or legal guardian of any accompanying children give consent and agree to Sliders photographing and/or recording(s) myself and any accompanying children and to use any such photographs and/or recording solely and only for Sliders advertising and promotional purposes. 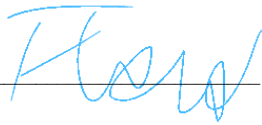
