* I acknowledge that the activities provided by Sliders are not available to pregnant women and that by accepting these terms I confirm that the participant(s) is/are not pregnant.

I agree and promise to ensure the participant(s) accept(s) to be responsible for any and all risks existing and subsisting in the activities. I acknowledge that participation in the activities is voluntary and that the participant(s) elect(s) to participate despite of the risks and agrees to accept the consequences of so doing.
