* I declare that I or the participants that I am parent or legal guardian of, are in a good state of health and free from any injury, medical condition, disease or illness. I acknowledge, that Sliders Center is not responsible if the player conceals any information related to his health condition.

* I acknowledge that the activities provided by Sliders are not available to pregnant women and that by accepting these terms I confirm that the participant(s) is/are not pregnant.

I agree and promise to ensure the participant(s) accept(s) to be responsible for any and all risks existing and subsisting in the activities. I acknowledge that participation in the activities is voluntary and that the participant(s) elect(s) to participate despite of the risks and agrees to accept the consequences of so doing. In the event of an injury or accident, I authorize Sliders to provide first aid and if necessary I will be transferred to the local hospital. * That the participant(s) will not use Sliders's facilities and activities whilst under the influence of any drugs or alcohol.

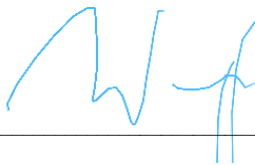
