I agree and promise to ensure the participant(s) accept(s) to be responsible for any and all risks existing and subsisting in the activities. * That the participant(s) will not use Sliders's facilities and activities whilst under the influence of any drugs or alcohol.

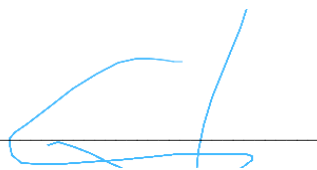
