I DECLARE THAT

1. Before my visit to Momentum Indoor Climbing Sofia and Climb Academy (the Centers), I have read and I agree with the [General terms and conditions for the Momentum Indoor Climbing Sofia website](#) and the [General terms and conditions for the Climb Academy website](#), the [Momentum Indoor Climbing Sofia Safety Instructions](#), [Climb Academy Safety Instructions](#) and with [the Rules of Use of the Facilities](#), located at the Centers, including the instructions of the Center's staff, as well as with the introduced [Momentum Indoor Climbing Sofia Anti Covid Rules](#), [Climb Academy Anti Covid Rules](#) on the territory of the Centers, which rules, instructions and anti-covid measures I have explained to the child, whom I accompany, in an appropriate manner, and I will follow the above rules, instructions and measures while I am on the territory of the Centers, taking care that my child follows them too.

2. When using the facilities in the Centers, I will take into consideration my skills and physical abilities, assessing the same in view of my child.

3. I am aware that the use of the facilities in the Centers by me (and by my child) is associated with certain risks, including the risk of serious injuries (including broken bones and fractures, bruises, abrasions, etc.) or fatal consequences due to slipping, stumbling, falling from a height, contact with the facility and equipment, an observer or another visitor of the Centers, etc. These risks depend on many factors, incl. the age, physical abilities and coordination of the participants in the activities, their experience and training, as well as mine and those of my child, the behavior of the observers and participants in the various activities, the type and quality of the used equipment, the time for response by the doctors from the emergency care system, the observance of the safety rules and the use of the facilities and the instructions of the staff of the Centers by the visitors of the Centers, etc.

4. Proceeding to the use of the facilities in the Centers by me and my child, independently and without an instructor, I declare that I have passed a training course provided by a qualified instructor, and release Collider Climbing EOOD, as manager of the Centers, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties from liability for the occurrence of the risks described in item 3 related to me or my child when they occur as a result of unsound decisions on my part in connection with the use of the facilities, equipment or incorrect assessment of my physical abilities, respectively the physical abilities of my child.

5. Proceeding to the use of the facilities in the Centers by me and my child under the guidance of an instructor providing services external for the Centers, I release Collider Climbing EOOD, as manager of the Centers, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties responsible for the occurrence of the risks described in item 3, related to me or my child, when they occur as a result of unsound decisions on my part in connection with the use of facilities, equipment or incorrect assessment of my physical abilities or due to improper and inconsistent instructions and actions taken by the instructor, providing services external for the Centers.

6. I am informed that when visiting the Centers by me and my child without an instructor or under the guidance of an instructor providing services external to the Center, Collider Climbing EOOD and its employees, including the instructors at the Centers, do not supervise and do not take responsibility for my actions and the actions of my child.

7. I am aware that the visit to the Centers and/or the use of the facilities in the Centers by me and my child is associated with a risk of contracting infectious diseases and/or transmitting infectious diseases, including, but not limited to, Covid-19, viral hepatitis, influenza, acute respiratory diseases, etc., for which risks Advent Facility Concepts and Management Ltd., as a manager of the Centers, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties do not take responsibility. These risks depend on many factors, incl. the manner of transmission of the contagious disease, the health condition of the visitors and/or the staff of the Centers, non-observance of the anti-epidemic measures introduced on the territory of the Centers by me and my child, as well as by visitors of the Centers, etc.
