

FOR ME AND MY KID

I, the undersigned, declare the following:

1. Before my visit to Momentum Plovdiv, I have read and I agree with the [General Terms and conditions for Momentum Plovdiv website](#) and with [Rules of use of the facility](#), located at the Center, including the instructions of the Center's staff on the territory of the Center, which rules, instructions I have explained to the child, whom I accompany, in an appropriate manner, and I will follow the above rules, instructions and measures while I am on the territory of the Center, taking care that my child follows them too.
2. When using the facilities in the Center, I will take into consideration my skills and physical abilities, assessing the same in view of my child.
3. Proceeding to the use of the facilities in the Center by me and my child, independently and without an instructor, I declare that I have passed a training course provided by a qualified instructor, and release Adventure Facility Concepts and Management Ltd., as manager of the Center, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties from liability for the occurrence of the risks described in item 3 related to me or my child when they occur as a result of unsound decisions on my part in connection with the use of the facilities, equipment or incorrect assessment of my physical abilities, respectively the physical abilities of my child.
5. Proceeding to the use of the facilities in the Center by me and my child under the guidance of an instructor providing services external for the Center, I release Adventure Facility Concepts and Management Ltd., as manager of the Center, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties responsible for the occurrence of the risks described in item 3, related to me or my child, when they occur as a result of unsound decisions on my part in connection with the use of facilities, equipment or incorrect assessment of my physical abilities or due to improper and inconsistent instructions and actions taken by the instructor, providing services external for the Center.
6. I am informed that when visiting the Center by me and my child without an instructor or under the guidance of an instructor providing services external to the Center, Adventure Facility Concepts and Management Ltd. and its employees, including the instructors at the Centers, do not supervise and do not take responsibility for my actions and the actions of my child.

7. I am aware that the visit to the Center and/or the use of the facilities in the Center by me and my child is associated with a risk of contracting infectious diseases and/or transmitting infectious diseases, including, but not limited to, Covid-19, viral hepatitis, influenza, acute respiratory diseases, etc., for which risks Advent Facility Concepts and Management Ltd., as a manager of the Center, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties do not take responsibility. These risks depend on many factors, incl. the manner of transmission of the contagious disease, the health condition of the visitors and/or the staff of the Center, non-observance of the anti-epidemic measures introduced on the territory of the Center by me and my child, as well as by visitors of the Center, etc.
