I confirm and agree that I am responsible for my child's actions on the territory of Orbita Fitness Club.

I agree to fully indemnify the relevant Club against any loss, liability, expense, claim and/or damages suffered by it arising as a result of my (my child's) participation in training sessions and/or use of the Club's facilities.

- ✓ **Deletion** of my and/or my child's personal data (i.e. to request the deletion of personal data relating to me in respect of which I have withdrawn my consent to processing);
- ✓ **Restriction** of the processing of my and/or my child's personal data (i.e. to request that the personal data continue to be stored, but not otherwise processed in the event I want the data to be stored for the purpose of defending legal claims);
- ✓ Receipt of the personal data, concerning me, in a structured, widely used and machine-readable format (**right to data portability**);
