Before my visit to Momentum Indoor Climbing Sofia and Climb Academy (the Centers), I have read and I agree with the [General terms and conditions for the Momentum Indoor Climbing Sofia website](#) and the [General terms and conditions for the Climb Academy website](#), the [Momentum Indoor Climbing Sofia Safety Instructions](#), [Climb Academy Safety Instructions](#) and with [the Rules of Use of the Facilities](#), located at the Centers, including the instructions of the Centers's staff, as well as with the introduced [Momentum Indoor Climbing Sofia Anti Covid Rules](#), [Climb Academy Anti Covid Rules](#) on the territory of the Centers and I will follow the above rules, instructions and measures while I am on the territory of the Centers.

2. When using the facilities in the Centers, I will take into consideration my skills and physical abilities.

Proceeding to the use of the facilities in the Centers by me, independently and without a instructor, I declare that I have passed a training course provided by a qualified instructor, and release Collider Climbing EOOD., as manager of the Centers, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties from liability for the occurrence of the risks described in item 3 related to me when they occur as a result of unsound decisions on my part in connection with the use of the facilities, equipment or incorrect assessment of my physical abilities.

5. Proceeding to the use of the facilities in the Centers by me and my child under the guidance of a instructor providing services external for the Centers, I release Collider Climbing EOOD., as manager of the Centers, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties responsible for the occurrence of the risks described

in item 3, related to me or my child, when they occur as a result of unsound decisions on my part in connection with the use of facilities, equipment or incorrect assessment of my physical abilities or due to improper and inconsistent instructions and actions taken by the instructor, providing services external for the Centers.

I am informed that when visiting the Centers without an instructor or under the guidance of a instructor providing services external to the Centers, Collider Climbing EOOD. and its employees, including the instructors at the Centers, do not supervise and do not take responsibility for my actions.

I am aware that the visit to the Centers and/or the use of the facilities in the Centers by me is associated with a risk of contracting infectious diseases and/or transmitting infectious diseases, including, but not limited to, Covid-19, viral hepatitis, influenza, acute respiratory diseases, etc., for which risks Collider Climbing EOOD., as a manager of the Centers, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties do not take responsibility. These risks depend on many factors, incl. the manner of transmission of the contagious disease, the health condition of the visitors and/or the staff of the Centers, non-observance of the anti-epidemic measures introduced on the territory of the Centers by me, as well as by visitors of the Centers, etc.
